CONVENTION STANDING RULES

1. For admission to the assembly hall, to facilitate identification and seating, members shall be required to wear the badge issued by the Credential Committee upon registration.
2. Debate on any motion shall be limited to a maximum of twenty minutes, ten minutes each allocated to proponent and opponent, who shall be recognized on an alternating basis.
3. No member shall debate or speak more than once on the same question, unless no other member is seeking to be recognized on the question. No member shall speak more than five minutes on a question.
4. Candidates for national office, or their designee, will be permitted ten minutes floor time to speak on their behalf.
5. Floor time for endorsements and seconding speeches will be limited to ten minutes.
6. These rules may be suspended by a two thirds vote of this convention.
